G1 = \$25 credit per month

G2, G3, G4 or G5 or I1 = 5% discount each month (applicable to base rate only)

NEW JOBS RATE DISCOUNT **

1-3 new jobs = 2% discount

7-9 new jobs = 6% discount

4-6 new jobs = 4% discount

✓ A Pre-Application List of each full-time position vacant and filled, job title, name of incumbent, and date hired. This will serve as a basis of comparison and include a date.

✓ A list of net, new positions, employee names and actual hire dates. These positions must not be reflected on the Pre-Application List and must not represent filling existing vacancies. .
