STANDARDS FOR STREET CLOSURE FOR NATIONAL NIGHT OUT

Applicants need to obtain encroachment permits from the Lodi Public Works Department for Activities within the Lodi City Limits Public Right-Of-Way.

STREET CLOSURE REQUIREMENTS:

1. 20-foot emergency access lane to be kept clear of obstruction at all times.
2. 15-foot clearance and accessibility to fire hydrants.
3. Proper notification of residents/proprietors within closure prior to event.
4. "Street Closed" signs/barricades at closure limits.
5. Signs are not to be attached to City of Lodi trees in any manner.
6. Stakes are prohibited in City of Lodi tree wells.
7. "No Parking" signs to be posted 24 hours prior to closure.
8. Hay bales are prohibited in public streets.
9. Port-A-Potties fronting private properties shall be at the owner's consent only. Prohibited placement at red curbs, fire hydrants, handicap ramps and driveways.
10. Inflatable jumpers/bouncers not allowed in the public right of way.

BARRICADE USAGE AND PROCEDURE FOR NATIONAL NIGHT OUT ONLY

For **National Night Out only**, barricades may be "borrowed" from the City of Lodi Municipal Service Center (MSC), 1331 S. Ham Lane.

- There is a \$100 security deposit.
- Make the check out to the "City of Lodi." It will be returned upon the return of the equipment.
- Pick up date is Monday, August 5th, 1 pm – 3 pm at the MSC.
- Return date is Wednesday, August 7th, 1 pm – 3 pm. Same location as pick-up.
- Call (209) 333-6740, press "0" to reserve and find out pick up times. You must have an encroachment permit. Supply is limited.
