LPD DISPATCH: Two adam one, two adam four.

OFFICER (2A1): Two adam one.

OFFICER (2A4): Woodrow and Joaquin

LPD DISPATCH: Twenty three Elderica Way for a fifty one fifty male causing a four fifteen inside the residence. Twenty three Elderica Way.

OFFICER (2A1): Two adam one copy.

OFFICER (2A4): Two adam four copy.

OFFICER (2A1): Two adam four from two adam one. Just for information, I'm coming from eight five five.

LPD DISPATCH: Ten four

OFFICER (2A1): Two adam one be checking the area. Subject left on foot prior to our arrival.

LPD DISPATCH: Copy two adam one.

OFFICER (2A1): Two...I...two adam four from two adam one, I think he's right over here by the basketball courts.

OFFICER (2A4): Affirm [unintelligible]

OFFICER (2A1): Two adam one.

LPD DISPATCH: Two adam one.

OFFICER (2A1): Two adam four he has a knife in his right hand. Two adam one he's refusing my commands.

LPD DISPATCH: Lodi to all units code nine hundred.

OFFICER (2S1): Two sam one en route.

LPD DISPATCH: Copy. Two adam one can I get your exact nine two six.

OFFICER (2A1): We're going back on to Elderica. I'm going to need you to call the R-P back, advise them to barricade the front door. We have a subject armed with a knife, very agitated, right hand.

LPD DISPATCH: Copy. Elderica and your cross?

OFFICER (2A4): Two adam four shots fired.

LPD DISPATCH: Copy shots fired.

OFFICER (2A1): Two adam one I got a man down. I need a ambulance code three and a supervisor.

LPD DISPATCH: Copy

OFFICER (2S1): Two sam one copy.

OFFICER (2A1): Two adam one we're going to need...uh...code three ambulance and fire. We are directly in front of...fifty five Elderica. We are code four. Suspect is in custody. We'll be administering first aid.

LPD DISPATCH: Copy in front of five...fifty five Elderica, code four, administering first aid.

OFFICER (2S1): Two sam one nine eight seven.

LPD DISPATCH: Copy two adam...two sam one.

OFFICER (2S1): Two sam one.

LPD DISPATCH: Two sam one.

OFFICER (2S1): Call the on call detective supervisor, also uh...Lieutenant Fernando if he's not. Advise him what I have.

LPD DISPATCH: Ten four.

OFFICER (2S1): Two sam one.

LPD DISPATCH: Two sam one go ahead.

OFFICER (2S1): Call the overlap units. Have them respond. I need them to uh, hit the streets.

LPD DISPATCH: Ten four.

OFFICER (2A3): Two sam one.
