According to the California Policy Center, public safety employees (police and fire) in California saw their total compensation increase 20%-30% more than the rate of inflation during the period 1991-2011.

According to transparentcalifornia.com, in 2015, over 200 Lodi city employees, including police and fire, made over \$100,000 per year in total pay and benefits.

A high sales tax is a regressive tax. It hurts the middle class, and people on fixed and lower incomes. It increases the cost of goods and services.

The City's problem is not a lack of sales tax revenue but that too much is being spent on compensation packages and spiraling pension benefits.
