The Community Development Block Grant (CDBG) is a federal grant program administered by the U.S. Department of Housing and Urban Development (HUD). The grant program provides communities with funds for public facility improvements, social services, economic development, affordable housing, fair housing, and other neighborhood improvements.

The 2019-2020 CAPER describes the projects and activities undergone during the 2019-20 CDBG program year, in which the City received \$624,641 in Federal CDBG funds. The community is invited to review and comment on the 2019-20 CAPER, which reports on the expenditures and accomplishments of the projects undergone in the 2019-20 CDBG program year.

The 2019-20 CAPER is available for public review and comment for 15 days starting September 2, 2020 and ending September 16, 2020. Once the public review period begins, you can view the CAPER at City of Lodi, City Hall, 305 West Pine Street, or the City CDBG webpage at <http://www.lodi.gov/183>.
